Hazleton City Council Meeting
April 17th, 2019

Hazleton City Council meeting held at the City Hall called to order with the pledge of allegiance at 7:00 PM by Mayor Miller. Council members present, Hayzlett, Lujan, Michels, Seiffert & Vawter. Also present: City Clerk Baych, Public Works Loomis. Attorney Prendergast & Fire Chief Dettbarn absent. Vawter/Michels moved to approve the printed agenda, Roll Call, All Ayes, motion approved. Vawter/Hayzlett motioned to approve the consent agenda, a) March 20th & 25th, 2019 minutes b) Clerk Report, c) Disbursements, Roll Call, All Ayes, motion approved.

PUBLIC COMMENT: Pat Arthaud asked about grass seeding on West Hayes and if Alliant would be returning this spring to repair right of ways. Loomis informed her Alliant would be here next week.

BUCHANAN COUNTY SHERIFF DEPT: The record of performance for the City of Hazleton was 108.62 hours with 98 records. Report on file.

PUBLIC WORKS: On 4/10 Flynn was in Hazleton to shave high spots on Hayes Street. Buchanan County will be in touch to discuss sewer man hole covers. Ken's Electric repaired the City Shop light and heater vent cover and will schedule repairs to Main Street Lights. Parts for the transfer switch are in and Best Services will install. On 4/15 spring discharge of the lagoons began. With all the excess water being pumped, the lagoons will need to be discharged 3 to 4 times this spring. The Well is pumping 65,000 per day. Mayor Miller informed the council on the huge consumption of water the trailer court is pumping, which indicated a major leak or several leaks in the court. Several attempts have been made to contact the court but no one returned the clerk calls. Council instructed clerk to send a certified letter to corporate office of the Hazleton Mobile Park addressing this issue. May 6th and 7th fire hydrants will be flushed. Loomis will get with Don Kleis on street repairs. Mayor Miller asked Loomis to let her know because she needs to talk with Kleiss regarding Westline Drive. Vawter asked about Prairie sweeping the streets. It will be placed on next month's agenda.

CITY CLERK: Baych informed council City Hall would be closed 4/18 for a user group meeting. She discussed the water bills and how they compared to the two months that were estimated.

COUNCIL DISCUSSION/ACTION: Ryan Brown with Brown Lane Insurance addressed the council on renewing the city insurance. Motion by Lujan/Hayzlett to approve renewing the city insurance but reducing the contents of 103 Hayes Street to \$1,000 and adding \$9,000 to equipment for the Schulte mower, Roll Call, All Ayes, motion approved. Lujan/Vawter moved to paint the flag pole at the museum and move the Museum sign to the back of the building, Roll Call, all Ayes, motion approved. Seiffert asked that it not interfere with snow piling. Vawter/Michels moved to approve purchase of a 28' ladder for \$260.00, Roll Call, All Ayes, motion approved. Lujan/Vawter moved to approve Public Works attend Consumer Confidence class, Roll Call, All Ayes, motion approved. Hayzlett/Vawter moved to approve Resolution 19-03 Property Lien, Roll Call, All Ayes, motion approved. Michels/Hayzlett moved to approve Resolution 19-04 Property Lien, Roll Call, All Ayes, motion approved. Hayzlett/Michels moved to approve Resolution 19-05 Property Lien, Roll Call, All Ayes, motion carried. Lujan/Hayzlett moved to approve Resolution 19-06 Property Lien, Roll Call, All Ayes, motion approved. Lujan/Hayzlett moved to approve Resolution 19-07 Abatement to previous lien 16-26, Roll Call, All Ayes, motion approved. Seiffert/Michels moved to approve Resolution 19-08 INRCOG Safety program, Roll Call, All Ayes, motion carried. Seiffert/Vawter moved to approve the bid from Scheels to grind only the stump in City Park for \$225.00, Roll Call, All Ayes, motion carried. Brewer will do cleanup, topsoil and grass seed. A discussion on installation of rain gutters at City Hall was held. Vawter/Michels moved to table installation and obtain additional bids, Roll Call, All Ayes, motion approved. Vawter/Michels moved to approve Fire Department Training for 403 Sufficool St E, Roll Call, All Ayes, motion approved. Lujan/Hayzlett moved to approve setting a public hearing to amend budget for May 15th council meeting, Roll Call, All Ayes, motion approved.

MAYOR REPORT: The insurance company did pay for the shop light repair minus the deductible. A letter was sent to a resident regarding a dog running at large. Mayor Miller informed the council she had clerk set up an addition utility account for a resident on Hayes Street until the Hayes Street project is resolved. Vawter informed Mayor that himself and Brewer built an enclosure for the water heater at the legion. Seiffert asked about change orders to the Hayes Street Project. Baych stated all minutes regarding the project have been sent to Prendergast.

COUNCIL COMMUNICATIONS: Hayzlett stated he would like to see the Sufficool Property that was acquired to become a Fireman's Park.

ADJOURN: Vawter motioned, Michels second to adjourn at 8:00 p.m.
