Hazleton City Council Meeting  
April 25<sup>th</sup>, 2018

Hazleton City Council meeting held at the City Hall called to order with the pledge of allegiance at 7:00 PM by Mayor Miller. Council members present, Hayzlett, Lujan, Michels & Vawter. Also present: City Clerk Baych, Public Works Loomis, Fire Chief Dettbarn & City Attorney Hosack. Vawter/Lujan moved to approve the agenda, Roll Call, All Ayes, motion approved. Vawter/Michels moved to approve the consent agenda: a) March 21<sup>st</sup>, 2018 minutes b) Clerk Report, c) Disbursements. Roll Call, All ayes, motion approved.

**PUBLIC COMMENT:** A citizen commented on what was left on the Hayes Street project. Mayor Miller stated street signs, backfill & seeding. No other comments made.

**BUCHANAN COUNTY SHERIFF DEPT:** The record of performance for the City of Hazleton was 85.95 hours with 92 records. Report on file.

**HAZLETON FIRE DEPARTMENT:** No report

**PUBLIC WORKS:** Loomis informed council on replacing a cam sensor on the generator, and parts on the LMI pump. All fire extinguishers have been inspected and spring discharge at the lagoons has begun. He discussed the street lights that are out. The CCR is complete and ready for publishing. The plow will be taken out to Blake for repairs. Vawter/Hayzlett moved to approve Dons Truck Sales bid for \$1148.10 for parts to the city plow, Roll Call, All Ayes, motion carried.

**CITY CLERK:** Baych informed council on the IMFOA Conference. Spring Cleanup is Saturday April 28<sup>th</sup>. She informed council on a citizens concern regarding the ditch on First Street South. Two new homes are being built in town.

**COUNCIL DISCUSSION/ACTION:** Lujan/Vawter moved to approve Amy Ekstrands council seat resignation, Roll Call, All Ayes, motion approved. Lujan/Vawter moved to advertise to appoint council member. A letter of interest must be submitted to the City Clerk by May 11<sup>th</sup>, 2018 by 4:00 p.m. Roll Call, All Ayes, motion approved. Bill Gibson addressed the council on 211 Third St S. Attorney Hosack informed Mr. Gibson he would need to submit to the council written out plans showing the exact improvements that would be made to bring the property in compliance with the ordinance. Hayzlett/Lujan moved to approve renewal of City Insurance with Brown-Lane (EMC), Roll Call, All Ayes, motion approved. Mike Dryden with Ament Engineering discussed the Westline Drive flooding issue. Vawter/Michels moved to approve Smith Excavating bid of \$39,837 to repair Westline Drive storm sewer, Roll Call Michels yes, Lujan yes, Hayzlett no, Vawter yes motion approved. A discussion on First Street ditch repair was held, Hayzlett will get additional cost estimates on the repair. Vawter/Hayzlett moved to approve Pronto's Cigarette License, Roll Call, All Ayes motion approved. Vawter/Lujan moved to approve Resolution 18-06 Declaring the policy of the City Of Hazleton regarding funding for the Hazleton Skate Park, Roll Call All Ayes motion approved. Lujan/Vawter moved to approve proclamation to Adopt Home Rule, Roll Call All Ayes, motion carried. Lujan/Vawter moved to get bids on endless gutter/roof & power wash of City Hall, Roll Call, All Ayes, motion approved. Harry Weber addressed the council and informed them of the materials that were used on First Street storm sewer park project. **CITY ATTORNEY REPORT:** Hosack informed council on abatement issues.

**MAYOR REPORT:** Miller informed council on the Hwy 150 meeting May 10<sup>th</sup>.

**COUNCIL COMMUNICATION:** Vawter requested new sign at City Brush Pile. Lujan suggested locking the brush pile and asked city hall hours be posted. Baych stated they are posted in the window. Lujan suggested a workshop for council to walk the city.
