Hazleton City Council Meeting  
May 16<sup>th</sup>, 2018

Hazleton City Council meeting held at the City Hall called to order with the pledge of allegiance at 7:00 PM by Mayor Miller. Council members present, Hayzlett, Lujan, Michels & Vawter. Also present: City Clerk Baych, Public Works Loomis, Fire Chief Dettbarn & City Attorney Hosack. Vawter/Michels moved to approve the agenda, Roll Call, All Ayes, motion approved. Vawter/Michels moved to approve the consent agenda: a) April 25<sup>th</sup>, 2018 minutes b) Clerk Report, c) Disbursements. Roll Call, All ayes, motion approved.

PUBLIC COMMENT: Hazleton churches will offer vacation bible school for 1<sup>st</sup> – 6<sup>th</sup> graders at the park beginning Wednesday June 13<sup>th</sup> from 5:30 p.m. – 7:30. A lite meal & activities will be provided. A citizen commented on concerns she had with the city.

CITY CLERK: Baych informed council on the new representative for Maquire Iron and upcoming renewal of contract and getting quotes to paint water tower.

COUNCIL DISCUSSION/ACTION: Vawter /Michels moved to approve Gene Seiffert as the appointment to fill the vacant council seat, Roll Call Lujan yes, Michels yes, Hayzlett no, Vawter yes, Motion approved. Lujan/Vawter moved to table the repair on First St ditch and Hayzlett will get additional information, Roll Call, All Ayes, motion approved. Lujan/Hayzlett moved to approve the removal of horseshoe stakes & poles in City Park, Roll Call, All Ayes, motion approved. Lujan/Vawter moved to approve Prairie Road Builders sweep Hayes St in the event the contractor doesn't have it completed prior to Hayes Days, Roll Call, all Ayes, motion approved. Michels/Lujan moved to approve the legion countertop addition cost of approximately \$100 to \$125, Roll Call, All Ayes, motion approved. Oath of office was given by clerk to Gene Seiffert for City Council appointment. Hayzlett/Vawter moved to approve Small City workshop to any member or staff that would like to attend, Roll Call, All Ayes, motion carried.
