Public Notice Hazleton City Council Meeting October 22nd, 2018

Hazleton City Council meeting held at the City Hall called to order with the pledge of allegiance at 7:00 PM by Mayor Miller. Council members present, Hayzlett, Lujan, Michels, Seiffert & Vawter. Also present: City Clerk Baych & Public Works Loomis. Fire Chief Dettbarn and attorney Hosack absent. Vawter/Michels moved to approve the agenda, Roll Call, All Ayes, motion approved. Seiffert/Vawter motioned to approve the consent agenda: a) September 19th minutes b) Clerk Report, c) Disbursements, Roll Call, All ayes, motion approved.

PUBLIC COMMENT: No public comment was given.

BUCHANAN COUNTY SHERIFF DEPT: The record of performance for the City of Hazleton was 80.53 hours with 73 records. Report on file.

HAZLETON FIRE DEPARTMENT: Miller informed Council Dettbarn was attending a fire chief meeting.

PUBLIC WORKS: Electric Pump performed annual service on lift stations and installed new impellers & rings on pumps in North lift station. In September Hazleton received 20" of rain resulting in the influent cell filling up rapidly. DNR is informed and additional drawdowns could result. Vawter asked about the wind vents on the Legion and 103 Hayes St W. Loomis got a slightly used one for \$50.00. Loomis will price additional vent caps for November council meeting. Vawter asked about the ravine & brush pile sign.

CITY CLERK: Gov Pay is up and running to receive debit & credit card payments. Bowers North has opened a new business at 206 Main St S. Vawter asked how the IMFOA Conference went and Baych informed council on classes she attended.

COUNCIL DISCUSSION/ACTION: Kristie Wildung (Iowa Regional Utilities Association) addressed council on the Emergency Back-Up Water Contract. She asked council if they had any feedback or questions regarding the contract. Vawter/Michels moved to approve city clerk attend budget workshop November 27th in Waverly, Roll Call, All Ayes, motion carried. Lujan/Vawter moved to approve Trick-ortreating October 31st from 5:00 p.m. – 7:00 p.m., Roll Call, All Ayes. Vawter/Michels moved to reschedule November's city council meeting to November 28th at 7:00 p.m., Roll Call, All Ayes, motion approved.

CITY ATTORNEY REPORT: Mayor Miller informed the council Hosack had given his notice and will no longer be Hazleton's city attorney. Heather Prendergast with Roberts, Stevens & Prendergast will be Hazleton's legal counsel moving forward.

MAYOR REPORT: Miller asked the council when reviewing council packets if you have questions for Loomis or Baych to contact them before the council meeting so they can be informed on what to bring to the meeting to answer your questions. Jean Gallmeyer with the Hazleton Skate Park informed Miller the skate park received a \$10,000.00 grant from Blackhawk County Gaming Commission. Miller asked the council to speak up when roll call is being done so it can be clearly heard on the tape.

COUNCIL COMMUNICATIONS: Vawter asked if the current issues with the city attorney are being reviewed by Prendergast, Miller stated yes. Hayzlett asked for owner of trailer on Third Street, he has possible option for its removal.
